January 14, 1929 - December 10, 2007

Alex Wisocki, 78, of N7608 Viking Drive, Fond du Lac, died Monday, December 10, 2007, at the Fond du Lac Lutheran Home. He was born on January 14, 1929, in Oglesby, Illinois, a son of Joseph and Elizabeth Belskis Wisocki. Alex moved to Kenosha in 1941 and was raised by his brother, Pat. He attended St. Peter's Catholic School, Lincoln Junior High and earned his GED while serving in the navy. Alex enlisted in the United States Navy in January 1946. His seven year tour of duty included serving in the Philippines on the U.S.S. Compton destroyer and with the Pentagon for two years. On January 31, 1948, he married Eugenia Irene Getschman, at St. George's Catholic Church, Kenosha. They moved to Fond du Lac in 1958. Alex was a salesman and deliveryman for Sealtest Ice Cream Company for over 20 years. He also was an independent distributor for ice cream companies for 14 years. He took early retirement in 1988 due to a disability. He was a member of St. Louis Catholic Church, an usher, lector, commentator, member of the Men's Club, and their Holy Name Society. Alex was also instrumental in moving the church picnic from the church to the county fairgrounds. He was most recently a member Presentation Catholic Church, North Fond du Lac. He is survived by his wife, Jean; eight children: Sondra (Morrie) Kutchek of Montello, Mark (Nancy) Mercury of Key West, Florida, Theresa (David) Opperman of Fond du Lac, Jeffery Wisocki of Houston, Geralyn Tovar of San Diego, Phillip (Sonia) Wisocki of Pompano Beach, Florida, Alyson (Michael) Koehn of Fond du Lac, Kristine (Michael) Hodorff of West Bend; 21
