August 10, 1922 - November 30, 2015

Clifford "Cliff" J. LaCrosse, 93, of Fond du Lac, died Monday, November 30, 2015, at Woodlands Senior Park. He was born on August 10, 1922, in Algoma, Wisconsin, a son of John and Julia Monfils LaCrosse. Cliff served with the United States Coast Guard during World War II. On August 26, 1944, he married Ella F. Koskubar in Sturgeon Bay, Wisconsin, celebrating 71 years of marriage this year. Cliff was a meat cutter and sausage maker in various grocery stores, retiring in 1980, after 30 years. He was a member of Sacred Heart Church of Holy Family Parish, American Legion Post #125 of Chilton, Disabled American Veterans Fond du Lac Chapter #11, serving as judge advocate. In 2011, he was honored to be chosen to take part in the Honor Flight. He was a volunteer for veteran's hospitals. He enjoyed making rugs and selling them at the farmer's market in Fond du Lac. He also enjoyed wood carving and traveling. He is survived by his wife, Ella F. LaCrosse; two children: Tony (Jean) LaCrosse of Oak Creek, Wisconsin and Donna (Terry) Ludkey of Marshall, Wisconsin; two grandchildren: Lisa (Lorid) Turner and Tera (John) Meinholz; three great-grandchildren: Krystal, Jacob, and Emily; a brother, Wilmer LaCrosse of Villa Park, California; a brother-in-law, Paul (Sigrid) Koskubar of Sturgeon Bay; and nieces, nephews, and cousins. He was preceded in death by his parents; a brother, Wilfred (Carrie) LaCrosse; a baby sister, Audrey LaCrosse; and a sister-in-law, Ann LaCrosse.
