



## Dennis G. Albrecht

January 1, 1952 - October 18, 2011

Dennis G. Albrecht, 59, of Van Dyne, passed away unexpectedly of heart failure on Tuesday, October 18, 2011. He was the first baby born at Ripon Hospital on January 1, 1952, to Marvin G. and Mae C. Miller Albrecht. He graduated in 1970 from Horace Mann High School, North Fond du Lac. On October 3, 1970, he married Nancy Harshbarger at Zion Evangelical Lutheran Church, Van Dyne. Dennis served with the United States Air Force from 1970-1974, serving one year in Thailand. After his military service, he farmed with his father, Marvin, in Van Dyne for 25 years. He attended Moraine Park Technical College and obtained a certificate in diesel mechanics in 2000. He continued farming the land while being employed with the Town of Friendship for the last 11 years as the township's road and maintenance man. He was a member of Zion Evangelical Lutheran Church, Van Dyne. Dennis enjoyed spending time with his wife, Nancy, his three children and their spouses, and six grandchildren, with another one on the way. He enjoyed traveling with his wife and friends. He recently built a pole shed and was looking forward to spending time out in his shop. He was a loving husband, father, and the best grandpa to his grandchildren.
