



Gerald "Jerry" E. Tuttle

October 24, 1927 - June 24, 2015

Gerald "Jerry" E. Tuttle, 87, of Fond du Lac, died Wednesday, June 24, 2015, at St. Agnes Hospital. He was born on October 24, 1927, in Birchwood, Wisconsin, a son to Charles and Cora Fossum Tuttle. Jerry was a graduate of Algoma High School, Class of 1945 and graduated with a degree in accounting from the University of Wisconsin-Madison. He served with the United States Army Air Corps, as a meteorologist, stationed in Iwo Jima and Guam. On September 23, 1956, he married Barbara A. Engh in Dearborn, Michigan. Jerry was an auditor for the Ford Motor Company in Dearborn, Michigan. He was a comptroller at Hi Ho and Koehring Company in Milwaukee, moving to Fond du Lac in 1972, to work as a comptroller at Kiekhaefer Aero Marine. Jerry began his accounting business, located in the Retlaw Building, Jerry Tuttle CPA, and later working for NFIB, for over ten years, until his retirement. Jerry was an active member of Good Shepherd Lutheran Church, where he served as treasurer. He was a volunteer with Blinded Veterans Association, Milwaukee, and a past member of the EAA where he also served as a docent. He was an avid golfer, enjoyed playing bridge, loved cutting wood at his cabin in Marinette County, and enjoyed sports, especially the Badgers. He is survived by a son, Charles Tuttle of Fond du Lac; a daughter, Susan Perry (friend, David Schmitz) of Fond du Lac; a granddaughter, Heather Perry of Fond du Lac; a brother, Wayne (Carole) Tuttle of West Bend; and a sister, Ardelle Lehmkuhl of Plymouth. He was preceded in death by his parents; his wife, Barbara, on June 7, 2015; and two

brothers-in-law and sister-in-law: Bud (Jane) Engh and Virgil Lehmkuhl. The funeral service will be held at 11:00 a.m. on Monday, June 29, 2015, at Good Shepherd Lutheran Church, 855 Martin Avenue, Fond du Lac, with Rev. Brett Naumann officiating. The visitation will be on Monday at church from 10:00 a.m. until the time of service. Entombment will follow in Rienzi Cemetery Garden Mausoleum with military rites conducted by the Trier-Puddy American Legion Post #75.
