



Kenneth R. Grimmer

August 12, 1950 - April 1, 2011

Kenneth Robert Grimmer, 60, of Fond du Lac, died Friday, April 1, 2011, at All About Life Rehabilitation Center. He was born August 12, 1950, in Fond du Lac, a son of Kenneth O. and Bernice M. Ollerman Grimmer. Ken graduated in 1969 from L.P. Goodrich Senior High School. In 1970 Ken was drafted into the Viet Nam War. He went kicking and screaming because he always believed in peace, not war. Thankfully, he was stationed in Hawaii and did not see action. He was honorably discharged on March 26, 1972. Though he wanted to forget his time in the service, we were all very proud of him. Through government loans (because of the service) he was able to further his education, graduating from the University of Wisconsin - Stout in 1976 with a Bachelor of Science Degree in Marketing. Ken went on to a career in the jewelry business, managing several different jewelry stores, until illness forced him into early retirement. He returned to Fond du Lac and his family home before entering All About Life in 2007. His life's hobbies included: reading, watching sports, and listening to his extensive collection of record albums. Ken was a master of trivia games and made sure we all knew it. He is survived by two sisters: Corliss (John) Christie of North Fond du Lac, and Kay Grimmer of Fond du Lac; one brother, Chris Grimmer (special friend, Lynn Richmond); nephews Bryan, Jamie, and Kyle Christie, all of North Fond du Lac; and Lynn Hartmann, special friend of the family. He was preceded in death by his parents and one sister, Karen Grimmer. The family will greet friends and relatives from 2:00 – 4:30 pm on Tuesday, April 5, 2011, at Mach Funeral
