Kenneth H. Roberts, 75, of Fond du Lac, died Wednesday, October 1, 2008, at Hospice Home of Hope, Fond du Lac. He was born on June 27, 1933, in Sheboygan, a son of Harold and Gertrude Smith Roberts. Ken was a graduate of Kohler High School and served with the United States Air Force until 1956. He worked as an engineer at the Kohler Company until 1962. Ken then went to Mercury Marine in Cedarburg, Fond du Lac, and Oshkosh until 1974. He worked independently, as a consulting engineer, until retiring at the age of 55. His volunteer activities included the volunteer fire department, Cub Scouts, Boy Scouts, Senior Scouts in Kohler, as well as coaching Little League in North Fond du Lac. Ken loved traveling, fishing, duck hunting, and golfing, especially at their winter home in Corpus Christi, TX, where he and Betty made many very good friends from all over the country and Canada. Ken was a member of Hope Lutheran Church.
